## Eligible Producers

Eligibility is limited to individuals contracted at the Producer level and is based solely on the Producer's personal production. The company will issue only one \$200 gift card per qualifying producer based on the producer's tax ID number regardless of what source through which the business is submitted. Producers contracted with agencies identified as Direct Marketers will not be included in this contest. Also ineligible are employees of certain financial institutions that prohibit their representatives from participating in these types of incentives.

## Contest Period
